Discussion: All of the appointees are former firemen and do a good job.

NEW BUSINESS

1. Community Support Committee Application for Historic Society Mr. Munn's Schoolhouse Project (Windows, Handicapped Door, Clapboards)

MOTION:

Selectman Arnold Jensen moved to approve the Oxford Community Support Committee Application for Oxford Historical Society, Inc., in the amount of \$15,000.00, for Mr. Munn's Schoolhouse Project for Windows, Handicapped Door and Clapboard; as approved by the Oxford Community Support Committee at their meeting held on 12/14/20. This was seconded by Selectman Heather Haney. All 3 Ayes. Motion carries.

Discussion: This is a great project to bring the museum up to code. The money comes from the power plant fund.

2. Promote Police Officers to Sergeant

MOTION:

Selectman Arnold Jensen moved to promote Corporal Buinauskas to rank of First Senior Police Sergeant, Officer Michael Roach to rank of Second Senior Police Sergeant and Officer Anthony Cipriano to rank of Third Senior Police Sergeant with a pay rate of \$39.59 per hour and effective 1/10/21. This was seconded by Selectman Heather Haney. All 3 Ayes. Motion carries.

Discussion: The town will now have three (3) sergeants, allowing for one sergeant on each shift. Discussion of the backgrounds of each officer, their responsibilities as sergeant and their pay. This action is allowing Oxford to move toward having their own police department and moving away from being a resident trooper town.

3. 589 Investments, LLC Option Contract for Purchase of Lot #17 East Commerce Drive – Approve and Authorize First Selectman to Sign

MOTION:

Selectman Arnold Jensen moved to approve the Option Agreement for Purchase of Real Property between the Town of Oxford and 589 Investments, LLC, of 29-1 Highland Road, for Lot #17 East Commerce Drive, as presented, and to authorize the First Selectman to sign; all as presented and recommended by the Economic Development Director. And whereas, the Town's Charter notwithstanding, Governor Lamont's Executive Order No. 7JJ, Paragraph 4, specifically authorizes the Town's Board of Selectmen to approve the proposed sale of real property to 589 Investments, LLC in lieu of holding a special town meeting. This was seconded by Selectman Heather Haney. All 3 Ayes. Motion carries.

Discussion: First Selectman George Temple indicated that the Town Attorney has requested this item be tabled.

This was seconded by Selectman Heather Haney. All 3 Ayes. Motion carries.

Discussion: Kyra Nesteriak, Parks & Recreation Director, explained that this person is replacing the former clerk, who retired.
