### **ACCEPTANCE OF MINUTES**

#### **1. 10/2/19 Regular Meeting**

##### **MOTION:**

Selectman Scott Flaherty moved to approve the 10/2/19 Regular Meeting minutes as presented. This was seconded by Selectman Arnie Jensen. All Ayes.

### **NEW BUSINESS**

**1. Funding Request for Storage of Oxford High School Lockers**

**MOTION:**

Selectman Scott Flaherty moved to approve the funding request, in an amount not to exceed \$1,940.00 and to be taken from Capital and Non-Recurring, for the storage of the Oxford High School Lockers which is part of the High School Locker Room Project and which is now scheduled for the end of the school year 2020; all as presented and requested by the School Facilities Manager in his email dated 10/10/19. This was seconded by Selectman Arnie Jensen. All Ayes. This matter will be forwarded to the Board of Finance.

Discussion: School Facility Manager George Renzoni explained the Oxford High School Locker Room Project. He stated that they were unable to do this project over this past summer. Therefore, there is a need to store the lockers until the next summer.

**2. Edward Jones/Martin Engstler Peddler's Permit – Approve**

**MOTION:**

Selectman Scott Flaherty moved to approve the Peddler's Permit for Edward Jones/Martin Engstler as presented with the following conditions:

- The Oxford Police Department must be notified daily of the area in town where you will be soliciting along with the hours.
- No soliciting in neighborhoods where it clearly states "No Soliciting" such as, but not limited to, Oxford Green, Meadowbrook Estates, River Bend Estates.

This was seconded by Selectman Arnie Jensen. All Ayes.

Discussion: First Selectman George Temple explained that the application is for a financial advisor and is restrictive. Identification must be carried and shown and the applicant must check in with the police department.

**MOTION:**

First Selectman George Temple moved to amend the motion to include ***applicant must have an identification badge*** along with the following conditions:

- The Oxford Police Department must be notified daily of the area in town where you will be soliciting along with the hours.
- No soliciting in neighborhoods where it clearly states "No Soliciting" such as, but not limited to, Oxford Green, Meadowbrook Estates, River Bend Estates.

**3. Hire Lifeguard**

**MOTION:**

Selectman Scott Flaherty moved to hire Nathan Badeau, of 14 Silano Drive, as a Lifeguard for the Parks & Recreation Department with a pay rate of \$11.00 per hour and a start date of Monday, October 21, 2019; as presented and requested by the Parks & Recreation Director in her letter dated 10/10/19. This was seconded by Selectman Arnie Jensen. All Ayes.

Discussion: Parks & Recreation Director Kyra Nesteriak explained that this position is for the open swim at the high school. There has been a lot of difficulty with hiring qualified lifeguards; we need more lifeguards. A copy of his certification is on file.

**4. Tax Refunds**

**MOTION:**

Selectman Scott Flaherty moved to approve the tax refunds, totaling \$5,987.48 and to authorize two signatures; as presented by the Tax Collector in her letter dated 10/10/19. This was seconded by Selectman Arnie Jensen. All Ayes.

**5. Report of First Selectman**

First Selectman George Temple took this opportunity to thank Selectman Scott Flaherty for his service, time and dedication as a Selectman as well as his help with the Oxford Middle School Project. He explained that Scott proved to be a great part of the team. First Selectman George Temple was very thankful that both parties worked very well together.


Kathy Johnson, of 68 Dorman Road, thanked Selectman Scott Flaherty for both parties working together.
