NEW BUSINESS

1. CT Humanities CT Cultural Funding Operating Support Grants <u>Resolution</u> – Approve and Authorize First Selectman to Sign

MOTION:

Selectman Arnold Jensen moved to approve the following CT Humanities CT Cultural Funding Operating Support Grants <u>Resolution</u> and authorize the First Selectman to sign the Connecticut Humanities Council, Incorporated Grant Agreement:

\$7,337.50

Discussion: Selectman David McKane asked what the legal fees totaling approximately \$33,000.00 were for. Finance Director Jim Hliva explained that item #3 is for a tax appeal. Item #4 is for a police matter, and item #5 is for legal expenses for the expert witness for the police matter and also for two appraisals for a matter, the Town Attorney is working on.

3. Report of First Selectman:

First Selectman Temple stated that the Town will be looking to appoint a new Tax Collector, since our current Tax Collector Ashley Schremmer resigned. This position is an elected position and will need to be filled by a Republican. The position does not require you to be certified, but the person hired must obtain the certification within a reasonable amount of time.

During the holidays, the Town experienced power outages due to fallen trees from the storm. We also experienced frozen pipes at the Middle School and at the Annex Building in Central Office All issues have been resolved and he thanked the Town employees and volunteers who had to work through Christmas and New Years.
