# Oxford Conservation Commission Inland Wetlands Agency

## REGULAR MEETING MINUTES

Tuesday, February 26, 2013

The Regular Meeting of the Oxford Conservation Commission/Inland Wetlands Agency was held in the Main Meeting Room of the S.B. Church Memorial Town Hall on Tuesday, February 26, 2013.

Meeting was called to order at 7:37 P.M. by Acting Chairman S. Purcella Gibbons

## AMENDEMENTS TO AGENDA:

D.E.E.P. findings on Emerald Borer

MOTION made by Commissioner B. Richter to accept the one amendment to the Agenda. Seconded by Commissioner E. Stewart.

All in Favor - 4-0

I.W.E. Officer A. Ferrillo stated that the Emerald Borer found was originally in the Naugatuck State Forest and D.E.E.P. checked in a 2 and half mile radius and found them in Oxford as well.

Acting Chairman S. Purcella Gibbons asked: Is there anything we can do about them?

I.W.E. Officer A. Ferrillo replied: There is nothing we can do, it is up to D.E.E.P. and that is why they placed an Ash Tree quarantine on the property.

## **OLD BUSINESS:**

Belmar Farms IW-12-115- discussion of vortechnic Unit and Smart sponge.

I.W.E. Officer A. Ferrillo explained to the Commission that the Town Engineer and Commissioner T. Adamski discussed the differences in the hydrodynamic separators vs. the smart sponge.

Commissioner T. Adamski went onto explain that our Town Engineer (Jim Galligan) agreed the hydrodynamic separators are not that good in separating oil and the only issue with adsorbent is that they require regular maintenance with a maintenance schedule and we need to make sure they are observing this. A letter will be put together from the town engineer to send to Belmar Farms engineer. The only question is, where will the adsorbent oil be put, will it be put in the catch basins or in the separator.

I.W.E. Officer A. Ferrillo replied that he will draft a letter regarding regular scheduled maintenance as well as where they are going to be placing the adsorbent. As in the motion, the Commission has decided after further discussion with the Town Engineer if we require smart sponge technology on the project.

Commissioner T. Adamski stated: I also spoke to the Town Engineer regarding the Crown Vetch planted around the High School Athletic Field and found out that has been widely used by the State Highway Department, it is now considered an invasive. I suggested that we don't need to use this type of invasive in Oxford again but there is nothing really we can do at the new athletic field, as it is already there. One of the advantages that they see is in the Fall season the plant falls over and forms a thatch and so now you don't have the raindrops in the soil but the root structure is not that great.
