*Motion made by Commissioner Shown to establish a policy to accept checks ONLY made out to OCAC. Motion seconded by Chairman Earley, all in favor, none opposed.

Commissioner Shown also made a motion to vote on a policy where individuals officially accept being the head of each arm. No vote taken. It was decided that further clarification was needed on exactly which programs we had which warranted a chair head, and to perhaps put a description of those programs in writing so as to be clear to its mission statement.

Commissioner Pace stated that it was imperative to have internet access during our commission meetings and it was determined that a letter needed to be sent to Selectman Temple to request computer access while our meetings are in session. The would greatly accommodate issues regarding our website and our ability to get on to our website for modifications, in addition to OCAC's other duties, i.e. our PayPal account.

The Gallery of Arts Show (GOA) date is May 16th, 17th, and 18th, 2014.

Art Director Peebles-Pelley submitted her contract to the board for the GOA 2014 show. It was signed off on by Chairman Earley, with a call for art, program book, sale of ads, membership program, and getting the awards sponsored to commence as soon as possible, with a GOA budget of \$5,050.00, the same as last year. Awards to be given at the GOA show, suggested, \$500.00 best in show, 300.00 for 1st place, \$200.00 for 2nd place, \$100.00 for 3nd place, and \$50.00 for honorable mention.

Art director Peebles-Pelley informed the Commission that the CT Chapter of Portrait Artists reception and meet the artists would be Tuesday, October 29th, 2012, from 7 p.m. to 9 p.m. The Commission decided that we would offer an award, both monetary and a plaque, to be voted on at the next meeting.

Next OCAC meeting is scheduled for Wed. October, 9th, 2012.
