<u>Treasures Report-</u> Susan Kovacs: Did not go over budget for year ending June 2020, \$1,039.08 was left over. Right on track with budget for 2021.

<u>New Business:</u> Mary LoPresti approached with task of helping out with secretarial minutes, agenda, for EDC, but unable to fulfill role. Ed Carver

reached out to Lois Caprio, Oxford Town Employee, to record minutes & file agenda to Margaret West, Town Clerk, & help Jeff with any projects he may need her for. Schedule of EDC Meetings would be every third Tuesday of each month through Dec. If any meetings are added on, they will be a special meeting. A motion was made by Mike Caprio & seconded by Scott Halstead to accept EDC Meeting Schedule, & Lois Caprio as secretary.

Motion passed unanimously.

Proposed Budget July 1, 2021: Conference Meetings increase of \$500; Advertising, increase in videos & software.

A motion was made by Mike Caprio & seconded by Steve Smith to accept proposed July 1, 2021 budget and submit to Board of Finance. Motion passed unanimously.
