REPORT TO THE ECONOMIC DEVELOPMENT COMMISSION FROM THE DIRECTOR.

Good evening folks,

As of tomorrow AM, I will not be available until May 12th. If you need an answer to a question within a reasonable time, please leave me an e-mail and I'll get back to you asap, when I find an internet salon. It has been a long year the ADZ, the elections, the onslaught of inquires on development here in Oxford and the day in and day out pressure of the job. You all know what I mean. I look forward to the next couple of weeks.

Enclosed is a projected proposed tax agenda that Dick Burke asked for at the yearly Finance Committee meeting two weeks ago.

As you will see the proposed tax estimate is broken into 3 different areas:

- 1] The Industrial
- 2] The Commercial
- 3] The Miscellaneous

These estimates are based on square footage per building and does not include personal property, cars, trucks, etc. Additional tax will added when the company takes possession and the Assessor computes additional tax due.

The \$ 945,350,063 does not include the tax due from Masonic Care that George is currently negotiating, or the Power Plant taxes that will be paid starting this month by CPV or the anticipated tax available once phase 1 @ the Town Center is completed.

Every day we have folks either moving in or considering a company moves to Oxford.

The 5 K race on Memorial Day is Oxfords next event and Fran Teodosia is the man in charge.

We are currently lining up sponsors for him...the proceeds go to the war vets and the Wounded Warriors, both great charities.

ATI LLC currently is preparing to move into 353 Christian St. on a lease w/ Dave Sippin an electrical parts manufacturer on GOVT contract for Electric Boat and Sikorsky. They are moving their Oregon operations to Oxford and will the first ADZ incentive recipient at the airport.

George is having lunch with them on April 30 @ 121 to meet CEO and CFO w/ Dave Sippin, property owner.

MAY'S ECONOMIC DEVELOPMENT COMMISSION DIRECTORS REPORT

April 2014 meeting was cancelled due to lack of a quorum.

The Commission has only 5 active Commissioners and all 5 are needed for a quorum.

So needless to say it is important for now until we fill these spots that all Commissioners attend our monthly meetings.

Enclosed is the updated April 22, 2014 report, with updates since then. I have just returned from 15 days away and little happened when I was not here..

Please note also that the Finance Board has chopped our budget to nothing for 2014-2015.

I have spoken to George about the remaining dollars we have left in our current budget

Approx. \$7,000. Working with Pat Blanko she has someone who can develop an Oxford Visual that can be used to promote the Town. George will have to get an OK from the Board of

Selectmen and then the Finance Board to allow these funds to be used for this project.

I want this Visual to be Pro Economic.

Dr. D'Sousa has broken ground on his medical arts buildings [3 and 50,000 s/f] on route 67. Scinto is the developer and has 2 of the buildings rented, so the third building is a go at this time.

Brennan's Shebeen, Irish Pub will hopefully be completed by Memorial Day or soon after.

Looks good so far!

The Hurley Group, New Haven, has passed muster with the P&Z last Tuesday night and will be completing the permit trail in the very near future. The 2 lots on Morse Rd. have been combined into a single unit and will be developed as expandable industrial units of 75,000 s/f.

ATI Corp. has finalized its lease with Dave Sippin for 17,000 s/f @ 353 Christian St. and has been designated the ADZ 's first recipient of the State's Economic Incentives of the Governor's Program. Many more to come.

There are a number of additional projects in the works and I'll bring them to your attention as we go.

We are all looking forward to "We got your 6" Walk and 5K Run on Memorial Day on Route 67.

A great cause to support the Vets!

From: Andy McGeever To: Dick Burke DICK, As per your request please find listed below new companies either already in ADZ. {Airport Development Zone) or going into the permit stage of setting up shop in Oxford. They qualify for the CAA incentives and the 60% tax base that will be paid to Oxford, 40% from state and 20% from the business. These figures are the result of information from Oxford's Assessor Eva Lintzner and Jim Hliva , Finance Director. The formula is simple: $s/f \times 104.47 \times .70\% \times 24.75 \text{ mil rate } x = 60\% \text{ taxes receivable.}$ These estimated taxes are for basic square footage and do include personal property, car, trucks etc. which will be determined at a later date. As you know this will add additional taxes to each property.
