A motion was made by Mr. VerNooy that there was no basis to sustain an ethical violation of Section 2.2.1. of the Code of Ethic for the Town of Oxford, as alleged in the Complaint dated October 10, 2012.

It was second by Mr. Lieder.

The motion was carried unanimously.

A motion was made by Mr. VerNooy that there was no basis to sustain an ethical violation of Section 4.2.2. of the Code of Ethic for the Town of Oxford, as alleged in the Complaint dated October 10, 2012.

It was second by Mr. Lieder.

The motion was carried unanimously.

A motion was made by Mr. VerNooy that there is a basis to sustain an ethical violation in the Complaint dated October 10, 2012 concerning Section 2.2.2. of the Code of Ethic for the Town of Oxford, only as to the language in that Section which states that "an official is to conduct oneself with propriety".

It was second by Mr. Lieder.

The motion was carried unanimously.

A motion was made by Ms Decker that the public official supplement the verbal apology made at the time of the statement with a written apology to the Commission and the Staff and that no further action would be recommended by the Board of Ethics.

It was seconded by Mr. Lieder.

The motion was carried unanimously.
