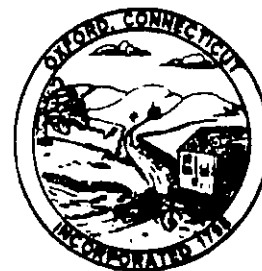

- F. Adjournment


Brett Olbrys moved to adjourn the meeting at 7:28 PM.


