The minutes of the regular monthly meeting of the Oxford Board of Fire Commissioners (BOFC) held in the Oxford Town Hall at 486 Oxford Road, Oxford, CT on Monday, Mar. 24, 2014 are as follows:

The meeting was called to order by Chairman Brian Francione at 7:09 pm with Pledge of Allegiance.

# Roll Call:

In attendance: Chairman Brian Francione, John Downs Sr., George Hamila, Mark Krassner, Mike Rubin, Joseph Chicoski, Asst. Chief Andy Coy, Asst. Chief Ron Prajer, Vic Noll. Absent: Chief Scott Pelletier.

MOTION made to accept the minutes of Feb. 24, 2014 meeting was made by Mark Krassner and seconded by George Hamila. All were in favor. MOTION carried.

#### **Public Session:**

Chairman Francione then opened the meeting to the Public. James Gies, 389 Oxford Rd. Oxford, CT requested to discuss comments to the proposed Fire Ordinance as well as Ed Roman, 92 Bowers Hill Rd. Oxford, CT. All in favor to further discuss comments under Committees and Workshops.

## Committees/Workshops:

Organizational Structure: On hold pending Ordinance

Ordinance: James Geis provided hand out to the Commission which detailed a number of concerns with the proposed Ordinance wording and reviewed these concerns with the Commission. Ed Roman stated he was representing Quaker Farms and stated that Quaker Farms truly appreciates the Board of Fire Commission putting together the Ordinance and taking the time to develop it. In addition as a topic of discussion, he also verbally outlined some concerns with a few sections of the proposed wording in 35.02. Ed Roman also asked if the meaning of the language in regards to Rejection or Approval of the Selection of Chiefs meant when the name is provided to the Commission does the Board have the right to reject the name/candidate provided. Chairman Francione added that only a recommendation is provided to the Selectmen. Ed Roman also suggested the following language be reviewed and possibly revised: in regards to duties of the Fire Commission, specifically the language of "but are not limited to"; re: preparation of the annual budget - his suggestion is that "in collaboration/or oversight with the Chiefs"; also in regards to preparation of the annual budget he asked if the word development is appropriate language. Mark Krassner suggested that the Ordinance subcommittee meet one final time and requested that the Commission be provided Quaker Farms concerns in a written statement for clarity and for discussion at the workshop. John Downs, Sr. voiced concern that the Commission has already sat down multiple times and finalized the proposed Ordinance wording with the Company representatives but it appears that the Company's keep putting stumbling blocks and asked if perhaps a group of OFD wants to not have a Board of Fire Commission. Ed Roman stated that the group just wants to have clarity in the proposed wording and to understand the language. Brian Francione added that the company representatives have done a great job and perhaps we should give it one more workshop.

John Downs, Sr. made a MOTION to have one final Ordinance workshop with the Board of Fire Commissions as well as all Company Representatives in attendance. Mark Krassner seconded the motion. All in favor. MOTION carried. Secretary to email all company representatives the date and time of meeting.

MOTION made by John Downs, Sr. to nominate Mike Rubin as Vice Chairman. Mike declined. Mark Krassner nominated George Hamila. Seconded by Mike Rubin. All in favor, MOTION carried.

MOTION made by John Downs, Sr. to nominate Brian Francione as Chairman. Seconded by George Hamila. All in favor, MOTION carried.

<u>Public Session:</u> Chairman Francione then opened the meeting to the Public. He asked three times if anyone from the Public would like to speak. With no responses, Public session closed.

## Good of the Commission:

Brian Francione commended the Chiefs and Officers for a job well done as the two recent house fires. John Downs, Sr. suggested the Chiefs ensure that next year the snow is cleared from around the two portable tanks.
