Jackson Cove - Summer Concerts begin on July 10.

The Commission discussed the OASIS committee's request to have a table for pamphlets at the concerts. Ken Maher, who is also on the committee said they are trying to get more public awareness of the opioid crisis.

The Commission was in favor of the committee's intent, but if they were allowed then other groups would have to be allowed. It was agreed that the intent of the summer concerts is to relax and have fun.

Discussion on having non-residents being able to purchase a resident beach pass, if they own property in town and pay at least \$1,000 in taxes.

Leap of Faith has asked to if they could hold 25 events at Jackson Cove. The group teaches the physically-challenged to water-ski. They commission felt that the park would be unable to accommodate the handicap vehicles and the number of people.
