# Oxford Planning & Zoning Commission Proposed Regulation Amendments:

Moratorium on the application and approval for any facilities for the sale, distribution or production of "medical marijuana" as defined by Connecticut General Statutes, for a period commencing on the date of the publication of the approval of this amendment until April 1, 2015, or such date when the Commission adopts zoning regulations for the sale, distribution and production of medical marijuana, whichever is first. The purpose of this moratorium is to enable the Commission to study and evaluate the issue, including the recently adopted state laws and regulations, and the potential land use impacts upon various sectors of the community.

Chairman Carver outlined the Public Hearing Procedures.
