Wednesday, June 23, 2021**


The Tax Collector Action Committee meeting was called to order at 9:05 A.M. Present were Ashley Schremmer, Jack Kiley and Jim Hliva.

Ashley presented the cases that are listed on the attached worksheet. She explained that these items just came to light as she began using a collection agency and the taxpayer's explained their case to the collection agency. The agency referred them to the Oxford Tax Collector. Since the Tax Collector can not write off accounts on her own, she requested this meeting. All of the items with the exception of Irene Kirby for 2010 related to the prior tax collector. Iren Kirby for 2010 was included in the write off list as she was attempting to get her records cleared up during the investigation. She no longer owned the car in 2010 but no corrections were made.

Jim Hliva made a motion to recommend to the Board of Selectmen the write off of \$7,072.02 in taxes receivable as detailed on the attached sheet. Jack Kiley seconded the motion. The vote was unanimous.

Jim Hliva made a motion to adjourn, seconded by jack Kiley, the vote was unanimous and the meeting was adjourned at 9:55 A.M.
