Review and Approval of Minutes MOTION by Bob Peck to approve the Special Meeting Minutes of 10/13/14. Second by Karl Borkowski. Vote – All ayes. Motion carried.

Applications Oxford Town Center (application 2014-9, sanitary sewer main extension)

Correspondence -1) Nafis & Young, 11/10/14, all issues from 9/26/14 letter have been addressed. 2) Mark Lancore, P.E., applicant's engineer, 11/5/14, response to Nafis & Young letter of 9/26/14.

Reviewed the revised drawings presented. All comments have been addressed. The drawings reflect a 12-inch sewer line.

Discussion on cost-sharing. For a 10-year period, anyone wanting to connect would have to pay the applicant. The applicant is installing the sewer line and the WPCA will maintain it.

WPCA has to approve before the applicant can get approval from the DOT.

MOTION by Bob Peck to approve application 2014-9 for sanitary sewer main extension with the following Conditions of Approval:

- 1. Applicant is required to pay all cost of plan review incurred by WPCA, which is to be paid prior to start of construction. 2. Applicant shall contact WPCA staff to schedule pre-construction meeting prior to start of any
- activity.
- 3. Applicant will be required to in Y for all properties along the line.

- Applicant will be required to in Y for all properties along the line.
 Applicant will be required to pay all costs of inspection of main line per regulations at a charge of \$4.00 per linear foot.
 Prior to the start of construction, the applicant is required to pay for the main line fee, 5,968 feet of main line @ \$4.00 =\$23,827.00
 All payments are to be made to the Town of Oxford.
 The applicant is required to supply, to the Town of Oxford, easements for any sewer line outside of the right of way. Subject to field conditions.
 Applicant to provide a stamped and a pdf copy of final plans. À.
