# Pulte Homes of New England (Oxford Greens)

Tony Schumann, Land Development Manager, Pulte Homes of New England (letter dated 12/23/13)

Mr. Schumann explained that Pulte Homes is requesting the bond for temporary pump station 6 be reduced. The pump station is complete and is 100% operational. The \$50,000 maintenance bond will remain in place until the permanent pump station is installed and operational.

Pump station 7 will be done under another bond and this bond will either roll into that bond or be released. Pump Station #7 will be permanent.

**MOTION** by Larry Ellis to reduce the bond from \$200,000.00 down to the 25% maintenance bond of \$50,000.00. For pump station 6, located at Oxford Greens, Phase 4. Second by Bob Peck. Vote – All ayes. Motion carried.

A request to reduce the bond will be sent to the Board of Selectmen.
