Old Business

\$48,000 quote for a variable frequency drive for Perkins Road pump station. The quotes are higher than originally expected.

The generator for Towner Lane pump station was installed and inspected by the Building Inspector.

Garden Homes pump station is 95% complete. They will be putting a roof over it and have to switch over the alarm.

Report from Staff

Reviewed the alarm history. Discussions on the number of alarms for the Towner Lane pump station. The reason for the power loss should be noted on the report. A letter will be written to Eversource inquiring about the number of times Towner Lane pump station has lost power.

The odor on Riggs Street, along the bridle trail, was from the swamp being low.

There were five new sewer connections.

A letter will be sent to the Seymour WPCA asking for a copy of the CTDEEP mandated improvements to the Seymour sewer plant. This is required before Oxford will pay \$52,774.53 (10%) of the total cost. A request will again be made that Oxford be made aware of any planned capital improvements. This way Oxford can budget for these expenses.
