The board reviewed the Fiscal Impact Statements for Great Oak Elementary School and proposed replacement of a portion of the Towner Lane Sewer Force Main

Great Oak Elementary School

The total amount to be borrowed or bonded (net of anticipated state grants) maximum amount. \$950,000. The estimated annual tax burden represented in mills, based upon the current Grand List of the Town based on a 4.5% interest rate is 0.05. With a 10% of current tax levy.

For Towner Lane Sewer Force Main

The total amount to be borrowed or bonded (net of anticipated state grants) maximum amount. \$2 million.

The estimated annual tax burden represented in mills, based upon the current Grand List of the Town based on a 4.5% interest rate is 0.11. with a 10% of current tax levy.
