MINUTES SPECIAL MEETING BOARD OF FINANCE – 2017/2018 BUDGET REVIEW OXFORD TOWN HALL APRIL 6, 2017 – 6:15 P.M.

Present: Chairman Jack Kiley; Tom Kelly; Lila Ferrillo; Sue Arpin; Robert DeBisschop; Dana Flach. Also present: James Hliva, Finance Director.

The Special Meeting was opened at 6:15 p.m. by Chairman Jack Kiley.

The purpose of the meeting was to review and vote on the FY 2017-2018 budget requests for the following departments:

TREE WARDEN

Leonard Beauprey, Jr., Tree Warden, is requesting \$85,000 for tree removal. Ms. Flach asked Mr. Beauprey if the request is enough for what needs to be done. Ms. Ferrillo recommended going with the \$85,000 for now and if he needs more money, he can come back to the Board. Ms. Flach countered that she believes \$100,000 should be allocated now rather than having the Tree Warden come back later in the year.

Mr. Beauprey requested \$500.00 for continuing education. In this case he needs to attend Tree Warden School.

He requested \$150.00 for supplies.

He is requesting a raise in the stipend from \$2,000.00 to \$3,000.00. Ms. Flach asked how the stipend gets paid. Mr. Hliva said now is twice a year.

EMERGENCY MEDICAL SERVICES (formerly Ambulance)

Mr. Kiley reviewed the financials of VEMS and questioned the contract amount of \$32,000.00 paid to VEMS. This amount is paid by all the Towns.

Mr. Jason Perrillo, Executive Director of VEMS, appeared to discuss the amount paid by the towns. He discussed the purpose of the fee. It enables an additional vehicle to be put into service so responders are spread out.

Mr. Kiley asked if VEMS is a 501C nonprofit and Mr. Perrillo said yes. Mr. Kiley began a discussion regarding the financials, specifically the profits. Mr. Perrillo did not have a copy with him. Mr. Perrillo stated that he keeps approximately \$200,000.00 on hand for payroll, fuel, etc. Because of the way VEMS is paid, he cannot afford to take the chance of not having enough money for these expenses. Mr. Kiley refers to Retained Earnings, which as a non-profit, they cannot have retained earnings. Upon review of the documents provided to him by Mr. Kiley, Mr. Perrillo stated that the numbers are not an accurate representation. These are unaudited

financials. There are many items not reflected accurately. Accounts receivables have not been adjusted. Mr. Kiley said that at VEMS' year end, he will schedule a meeting to review the accurate year-end numbers. He asked why VEMS still charges \$32,000 to the towns when they show a surplus.

Mr. Hliva questioned Mr. Perrillo regarding the settlement reached between Derby and VEMS.

A discussion ensued between the Board members regarding the amount requested by Emergency Medical Services.

Ms. Ferrillo noted that Ms. Taggart had asked for a reinstatement of wages. Ms. Hliva explained how the figure was arrived at. Mr. Kiley noted that salaries are total of \$238,000 for four people, broken down as follows: Director, \$94,908; Assistant Director, \$61,800; Operations Supervisor, \$51,963; Training Coordinator, \$30,000.

Ms. Flach questioned the amount of \$15,000 for Vehicle Maintenance. Mr. Hliva gave the explanation. The Board of Selectmen has tabled the request for additional monies.

Mr. Kiley made the Motion to approve \$166,373.00; Ms. Ferrillo seconded the Motion. A vote was taken.
