The request is for main line sewer inspection at Oxford Commons. One of the conditions of approval for the project was that the contractor pays for a full time inspector hired by the Town. There is no cost to the Town. The monies from the contractor will go into General Fund and the money will be released from General Fund. This will go to Town Meeting.

Mr. Hliva read the list of additional bids from three other companies (Stone Construction Co.; Griffin Brothers Excavating; and Earthworks Excavation & Landscaping, Inc.).

The reason for the transfer from Finance Contingency is to speed up the project. If this request had to go to Town Meeting, it would delay the start of the project.

Mr. DeBisschop made a Motion to move \$26,163.00 out of Finance Contingency for the installation of the Fire Dept. Septic System. Mr. Grant seconded the Motion.
