ACCEPTANCE OF MINUTES

1. 12/1/21 Special Meeting

MOTION:

Selectman Arnold Jensen moved to approve the 12/1/21 Special Meeting minutes as presented. This was seconded by Selectman David McKane. All 3 Ayes. Motion carries.

APPOINTMENTS

1. Cultural Arts Commission Re-Appointment Clarification

MOTION:

Selectman Arnold Jensen moved to *clarify* the motion made at the 12/1/21 Special Meeting with regards to the Cultural Arts Commission Appointment. The actual term for this appointment began on 1/1/19 and expires on 12/31/21. The motion shall read:

First Selectman George Temple moved to appoint Ellen Fox to the Cultural Arts Commission with a term to commence immediately and expire on 12/31/21. This was seconded by Selectman Arnold Jensen. All 3 Ayes. Motion carries.

2. Community Support Committee Appointment

MOTION:

Discussion regarding how Mr. Baxter is a great fit and really in tune with the needs of the Veterans, kids and the community.

3. Elderly Commission Appointment

MOTION:

Selectman Arnold Jensen moved to appoint Edith Witham to the Elderly Commission with a term to commence immediately and expire on 12/31/24. This was seconded by David McKane. All 3 Ayes. Motion carries.

DISCUSSION:

Discussion regarding Mrs. Witham being well liked and a good fit.

4. Board of Ethics Re-Appointments/Appointments

MOTION:

Selectman Arnold Jensen moved to re-appoint David VerNooy to the Board of Ethics with a term to commence immediately and expire on 12/31/23. This was seconded by David McKane. All 3 Ayes. Motion carries.

DISCUSSION:

First Selectman George Temple stated that Mr. VerNooy is about as ethical as you can get and the Board of Selectmen are glad to have him on board.

MOTION:

Selectman Arnold Jensen moved to re-appoint Ben Blue to the Board of Ethics with a term to commence immediately and expire on 12/31/23. This was seconded by David McKane. All 3 Ayes. Motion carries.

DISCUSSION:

First Selectman George Temple commented that Mr. Blue is well known and a real good guy with unquestionable ethics.

MOTION:

Selectman Arnold Jensen moved to re-appoint Paul Schreiber to the Board of Ethics with a term to commence immediately and expire on 12/31/24. This was seconded by David McKane. All 3 Ayes. Motion carries.

DISCUSSION:

First Selectman George Temple stated that Mr. Schreiber is very well known. He was a former first selectman, he takes his stuff seriously and is doing a great job.

MOTION:

First Selectman George Temple moved to *table* re-appointing Laura Denslow to the Board of Ethics. This was seconded by Selectman Arnold Jensen. All 3 Ayes. Motion carries.

MOTION:

Selectman Arnold Jensen moved to re-appoint Mary Androski to the Board of Ethics with a term to commence on 1/1/22 and expire on 12/31/25. This was seconded by David McKane. All 3 Ayes. Motion carries.

DISCUSSION:

Discussion was had that Mrs. Androski has been on the board for over ten years and does a great job. She is also a lawyer, which is beneficial to have on board for technical points.

5. Parks & Recreation Commission Re-Appointments

MOTION:

Selectman Arnold Jensen moved to re-appoint Glen Schumitz to the Parks & Recreation Commission with a term to commence on 1/1/22 and expire on 12/31/24. This was seconded by Selectman David McKane. All 3 Ayes. Motion carries.

DISCUSSION:

Discussion was had in regards to what a great job Mr. Schumitz is doing and how involved he is. Comments were added how he genuinely cares about Parks & Recreation and the town. As Mr. Schumitz was in the audience, First Selectman George Temple told him that he was doing a great job. Mr. Schumitz thanked the First Selectman.

The First Selectman went on to congratulate the entire Board for everything they have done and accomplished all throughout Covid and how they reconfigured everything to ensure public safety; they made lemonade out of lemons. The Board was able to continue and achieve things that many towns just abandoned. In particular though the guidance of the Director, Kyra Nesteriak, and Chairman Glen Schumitz.

MOTION:

Selectman Arnold Jensen moved to re-appoint Greg Baktis to the Parks & Recreation Commission with a term to commence immediately and expire on 12/31/23. This was seconded by Selectman David McKane. All 3 Ayes. Motion carries.

DISCUSSION:

Chairman Glen Schumitz stated that Mr. Baktis is an excellent choice.

MOTION:

Selectman Arnold Jensen moved to re-appoint Jennifer Wolyniec to the Parks & Recreation Commission with a term to commence immediately and expire on 12/31/23. This was seconded by Selectman David McKane. All 3 Ayes. Motion carries.

DISCUSSION:

Chairman Glen Schumitz commented this is another excellent choice. Mrs. Wolyniec is very involved and has kids as well, which aides to keep the Board in the know.

MOTION:

Selectman Arnold Jensen moved to re-appoint Jason Opotzner to the Parks & Recreation Commission with a term to commence immediately and expire on 12/31/23. This was seconded by Selectman David McKane. All 3 Ayes. Motion carries.

DISCUSSION:

Chairman Glen Schumitz commented that Mr. Opotzner is new, doing great and has done a great job so far.

6. Planning & Zoning Commission Appointment

MOTION:

Selectman Arnold Jensen moved to appoint Edward Rowland to the Planning & Zoning Commission with a term to commence immediately and expire on 11/21/23. This was seconded by Selectman David McKane. All 3 Ayes. Motion carries.

DISUCSSION:

Discussion was had that Mr. Rowland had been on the board before, he has deep roots in this town and the Board wholeheartedly supports this.

7. Planning & Zoning Commission Alternate Re-Appointment

MOTION:

Selectman Arnold Jensen moved to re-appoint Joshua Dykstra to the Planning & Zoning Commission as an Alternate with a term 1/1/22 immediately and expire on 12/31/23. This was seconded by Selectman David McKane. All 3 Ayes. Motion carries.

DISCUSSION:

Discussion was had that Mr. Dykstra has been on the commission for quite some time. He knows and understands the regulations well. There has been nothing but good things heard about him. The board congratulated him and told him to keep up the good work and he has their support. Mr. Dykstra was present and thanked the Board.
