# 1. 12/6/17 Regular Meeting

#### **MOTION:**

Jeff Haney moved to approve the 12/6/17 Regular Meeting minutes as presented. This was seconded by Scott Flaherty. All 3 Ayes. The motion carries.

#### **APPOINTMENTS**

#### 1. Animal Control Assistant As-Needed Appointment

#### **MOTION:**

Jeff Haney moved to appoint Robert Costigan, of 300 Chestnut Tree Hill Road, as the Animal Control Assistant As-Needed at a pay rate of \$15.50 per hour effective immediately. This was seconded by Scott Flaherty. All 3 Ayes. The motion carries.

Discussion: First Selectman George Temple stated this was as needed by Animal Control. Selectman Jeff Haney stated these were extenuating circumstances, two people have left Animal Control recently.

# 2. Cultural Arts Commission Appointment

Jeff Haney moved to appoint June Maciolek, of 27 Larkey Road, to the Cultural Arts Commission with a term to commence immediately and expire on 12/31/19; as presented and recommended in their letter dated 11/10/17. This was seconded by Scott Flaherty. All 3 Ayes. The motion carries.

# 3. Economic Development Commission Appointment

Discussion: First Selectman George Temple stated they have been involved with the town forever and they will do a great job.

# 8. Water Pollution Control Authority Re-Appointment

#### **MOTION:**

Jeff Haney moved to re-appoint Larry Ellis, of 23 Macintosh Drive, to the Water Pollution Control Authority with a term to commence immediately and expire on 12/31/20; as presented and recommended in their letter dated 12/11/17. This was seconded by Scott Flaherty. All 3 Ayes. The motion carries.

Discussion: First Selectman George Temple stated this is a good appointment, Larry is a hard worker and his attendance is good.

- 2. Virtual Towns & Schools Service Contract Addendum Approve and Authorize First Selectman

#### **MOTION:**

Jeff Haney moved to approve the Virtual Towns & Schools Service Contract Addendum, as presented, and authorize the First Selectman to sign; as presented and recommended by the Town Clerk/Website Coordinator. This was seconded by Scott Flaherty. All 3 Ayes. The motion carries.

Discussion: Town Clerk, Margaret West-Mainor stated that the company for the website is phasing out the current platform and offering the new one to us at a discounted rate if we sign on now. Selectman Jeff Haney asked what Margaret meant by "phasing out" Margaret stated that this is a totally new platform it is user friendly and the company will only do municipalities, I recommend this and think it best to stay with this company. George Temple asked Jim Hliva if this had to go to Board of Finance, Jim stated no it did not. Margaret West-Mainor explained it will be an addendum to the contract.

#### 3. Hire Assessor Clerk

#### **MOTION:**

First Selectman George Temple moved to hire Jane Davidson as the Assessor Clerk at a pay rate of \$16.59/hour and a start date of January 8, 2018. This was seconded by Scott Flaherty. 2 Ayes, Jeff Haney abstained. The motion carries.

Discussion: Scott Flaherty asked if this was supposed to be available to present employees, George Temple stated that no one from the union bid on the job and the job was posted on the website for 5 days. There was a screening committee for the job, the committee consisted of Jim Hliva and Kristyn Rosa.

# 4. Review Community Support Committee's Grant Application – Approve Recommendations

#### **MOTION:**

Jeff Haney moved to approve the Community Support Committee Grant Application submitted by the Oxford Agricultural Advisory Committee for the amount of \$15,000.00 to be used to assist in the cost of the School Garden project; all as approved by the Community Support Committee on 12/28/17. This was seconded by Scott Flaherty. All 3 Ayes. The motion carries.

Discussion: First Selectman Temple asked Todd Romagna if this was what he requested, Todd said yes, and explained it was "more of a match", they had other donors to make up the total of \$32,500 for the whole project. They will be putting in a hothouse & storage shed. George explained that they had negotiated with the power plant to donate \$50,00.00 a year for community development. Scott Flaherty asked if this was just for students or the entire community, George explained that at the present time it was just for students but possibly for the whole community in the future.

Jeff Haney moved to release the Maintenance Bond in the amount of \$50,000.00 (Surety Bond No. 268002147) for Pulte Home's Phase 4, Pump Station #6; as recommended by the Water Pollution Control Authority in their letter dated 11/30/17. This was seconded by Scott Flaherty. All 3 Ayes. The motion carries.

Discussion: First Selectman George Temple asked Fire Chief Scott Pelletier if this was OK. Scott Pelletier stated yes it is.

# 8. Connecticut Homeland Security Blanket Resolution – Approve and Authorize First Selectman to Sign

Temple, as First Selectman of Oxford Board of Selectmen, is authorized and directed to execute and deliver any and all documents on behalf of the Oxford Board of Selectmen and to do and perform all acts and things which he deems to be necessary or appropriate to carry out the terms of such documents, including, but not limited to, executing and delivering all agreements and documents contemplated by such documents.
