# 5. Twin Brooks Subdivision Plan and Upper Portion Property Transfer to Oxford Housing Authority – Approve

### **MOTION:**

Selectman Haney moved to approve the subdivision of the Twin Brooks' property, identified on Tax Assessors map as Map 19, Block 28, Lot 23 and Map 19, Block 28, Lot 10, and to approve the transfer of the upper portion of this property to the Oxford Housing Authority for the construction of 80 new affordable senior housing units, as depicted in the subdivision map prepared by Town Engineer James Galligan; as presented and requested by the Grant Writer in her letter dated 12/20/12. This was seconded by Selectman McKane. Discussion: First Selectman Temple indicated that he met with Attorney Condon to discuss this matter and there are open issues that need to be addressed. He added that the relationship between the Town and the Oxford Housing Authority needs attention. Selectman McKane commented that this must be separate from Crestview Ridge and this was agreed upon. Selectman McKane made no comment as to whether or not he supports the project. He also commented that the group to assess the needs of the schools may find that this property is a good location for a school.

# 6. Report of First Selectman

First Selectman Temple commented that the Town received a complement on the Newtown High School blog for the green and white ribbon for the fire house and we were thanked for it.

Due to recent tragic events, the Town is looking at the security in the schools and police have been present in the schools recently. The Selectmen will meet with Superintendent Connellan next week to discuss the matter. The Daisies have made green and white ribbons that can be pinned on a garment and are being sold for \$1 each. Proceeds from the sale will cover the cost for one or more Newtown Daisies to attend camp in the summer.

He commented that a donation was made to the animal shelter in the amount of \$250. The donation came from a man in Beacon Falls who heard that the parents of a girl who was killed in Newtown had notified the public that she would have wanted donations to be put toward the care of animals.
