Present: First Selectman George Temple, Selectman McKane and James Hliva, Finance Director.

Discussion of Capital plan took place. Adjustments were made to finalize the capital budget to be presented to Town Meeting. First Selectman Temple noted that he is including \$350,000 for school security. This amount was not requested by the Board of Education and their school security improvements were split over several years. He wants the school security done as a priority to protect our children.

Discussion then switched to the operating budget. Based on the Capital plan, the Selectmen added \$499,355 to the capital projects of the Municipal budget. This included capital purchases and the yearly cost of new leases as recommended in the Capital plan.

The selectmen agreed on a municipal budget of \$14,330,183 to be voted on at the Board of Selectmen's regular meeting later today at 7:30 p.m.
