<u>Audience of citizens</u>- Mr. Lanier updated the committee on what our funding has allowed the Conservation Commission to accomplish. The committee was thankful and appreciated the update. It was hoped that others would come back to the committee as well with updates. We did discuss that the request for the \$9,900.00 was approved at our last meeting. We will be sure that it gets on the agenda for BOS' next meeting.

Review any applications:

CHILL Team- Cooperative Help for Independent Living Locally- The application is for a pop up market which would expose young adults with ID to job skills, employment opportunities in our community. The request was \$1,100. The committee felt this was a perfect example of helping members of our community. Motion by Mr. Schumitz, seconded by Mr. Rotzal. Motion was approved all in favor

Oxford Babe Ruth- This matter was tabled from our February meeting. We had wanted the group to update us on their permitting process before approval. The requested amount was \$21,780.00. Mr. Napomiceno and Mr. Mullen discussed that they have their permits and are ready to begin work. Both left at 7:30. Motion by Ms. Sherman, seconded by Mr. Schumitz to fund \$10,000.00. Motion was approved all in favor.

Oxford Quarterback Club - The application is to assist with funding for the club's community activity surrounding the Town wide clean up and fundraising. The request was for \$2,000.00. The committee

discussed and Mr. Schumitz motioned to approve \$500.00 for use for the town wide clean up, seconded by Ms. Sherman. Motion was approved with all in favor.

Mr. Romagna arrived at 7:50

GOMS Softball Field Improvements- The application is to repair the softball field at Great Oak Middle School which is used by GOMS softball and Oxford Little League which is girls' softball in town. The request was for \$13,329.00. This matter was tabled on April 8, 2018 for additional information. There has been some discussion with the BOE and members of the town. Motion by Mr. Schumitz to approve funding in the amount of \$6,664.50 contingent on the organization obtaining funding from the town, seconded by Mr. Rotzal. Motion approved with all in favor

Motion by Mr. Rotzal, seconded by Mr. Romagna to adjourn.
