Additions to the Agenda - There were none. There will be no Executive Session.

<u>Minutes</u> – There were no corrections. Commission Chairman Burns entertained a motion to accept the September 28, 2018 minutes as stated. Commissioner Barrett made a motion to accept the September 28, 2018 minutes as stated, and was seconded by Commissioner O'Connell. Commission Chairman Burns asked all those in favor to vote Aye. All were in favor.

Treasurer's Report -

Commission Chairman Burns entertained a motion to defer reading the treasurers report until the next meeting due to the treasurer(Commissioner Peter Aiksnoras) being absent. All were in favor.

Management and Budget - There are no vacancies at Crestview Ridge.

- There are 71 people on the elderly waitlist and 18 people on the elderly disabled waitlist.
- There were no unit inspections during this period.
- During this period, there were 7 work orders; 2 have been completed and 5 have not. It took a total of 3 days with an average of 1.5 day to complete.
- The Deputy Fire Marshall, Mark Krassner has performed the annual Inspection on October 4, 2018.
- A deodorizer was hung up outside the maintenance room.
- Stoppers were installed in the laundry room's windows to restrict opening height.
- The Nature's Edge cleared the brush between building B and C. They also put mulch down around the recently planted trees on the property.

- Buddy's Fuel came and ignited the pilots in all the rooms that have requested propane heat.
- Suburban Propane filled the propane tanks.
- Huntington power serviced the generator.
- On October 24, 2018 there was a Tenant and Management Meeting. The following items were discussed:
- The Bulbous lights are out in front of Building C.
- Tenants want the pine trees/bushes removed from the island in front of Building D.
- Tenants want the van parked in the handicap spot removed. The van is never used.

<u>Old Business</u> – The window locks for the upstairs and downstairs laundry rooms have been installed. It will be looked into getting stoppers for all lower level windows.

- Flagpole It's in process, it should be all set in a couple weeks.
- The 2019 Meeting Dates. All were in favor.
- There is a meeting set for November 7, 2018 to get on the schedule to pave the roads and fix the curbs.
