Adult book discussions held.
Planning and Building Committee met and concept of new library was presented. No commitment has been finalized. Next meeting scheduled December $8^{\text {th }}$ which includes a draft of a lease agreement for library space.
Holiday Fundraiser run by the Friends of the Library has started and will continue through December $15^{\text {th }}$. Tickets for Holiday Fundraiser will also be on sale during the Town Tree Lighting. Next Friends meeting scheduled for December $4^{\text {th }}$.
Library received grant from Kathryn Mattheis Foundation for $\$ 8400.00$ to purchase an installed screen, mounted projector, and electrical box. All these items have been installed and have already been utilized. These will be hooked up the cable as well, once Comcast has come, Paperwork for reimbursement check will be sent in before Thanksgiving; Board should receive it in December.
