At a recent meeting of the Library Board their meeting minutes had some questions on Finances and they were going to write to you.

The following are the answers to the Questions.

Question: Strong estate Monies where are they.

Answer: The Town has only received \$77,902.81 to date. The remaining funds have not been distributed by the Estate of Marion Strong. From the date of receipt which was October 2012 until June 30, 2013 the money was in Naugatuck Valley Savings Bank. On July 1 the funds were transferred to Naugatuck Savings Bank. The balance in the account as of July 1, 2013 was \$77,954.76. The current balance is \$78,006.75

Question: Is there a separate account for Library Building Fund and if not, how do we set one up

Answer: There are two accounts for the Library Building fund. The first has been in existence for many year. It is at TD Bank and the balance as of October 31, 2013 is \$4,822.14. The second account is in the Town of Oxford Special Activity Fund. The current balance is \$200.

Question: Where are the monies appropriated from the Polka Fest (approximately \$10,000)?

Answer: I have never heard of the Polka Fest and there is no separate account. The Library does have an account for Gifts and Bequests in the Town of Oxfords Special Activity account. There is currently \$59,110.36 in the Gift and Bequest account

Question: What financial institution is holding the grant monies?

Answer: The grant monies are being held at Naugatuck Savings Bank. The current balance is \$5,928.73

Question: Where are the \$4,900.00 bequest monies from 25 years ago?

Answer: I do not know what funds you are referring to but there are the two accounts listed above. Library Construction with a balance of \$4,822.14 and the Gift and Bequest account with a balance of \$59,110.36
