Posted rules - sign will be at the main entrance and on both the right and left side of the beach. Most of the other signs at the entrance will be removed.

Debbie Gatto and the Aquatics Director will be revising the lifeguard procedures for Jackson Cove. The swimming pool will be included in the revised procedures.

Discussion on a request from a non-resident, who's husband works in town, for a pool pass. The Commission noted that if it was done for one person, than others would want to do the same.

Debbie Gatto suggested opening the pool up to a limited number of non-residents at a higher fee. She also suggested doing the same at Jackson Cove. The Commission discussed the idea.
