Other Business

Lily Park – The caulking on the slide was done, but there is still an issue. Discussion on the step to the climbing pole being too far of a reach for children. It is a safety concern. As adjustments cannot be made, the pole would have to be removed.

A set of bleachers at Oxford Center School were removed after a child was injured. Several children have been injured on the playground at the school.
