Amendment of Agenda

MOTION Kelly Weymer moved to add Peddlers' Permits to the agenda. Second by Kenn Maher. Motion unanimously approved.

Audience of Citizens

Youth Basketball - Jeff Zareski from Oxford Youth Basketball updated the Commission on the spring program. The goal of the program is to teach kids advanced skills that will help them if they play high school level basketball. There are 36 boys and 20 girls registered. They will have two practices a week and scrimmages against other leagues/organizations. Due to limited gym availability, they will practice in Oxford as well as rent gym time from Seymour and TSA.

Tournaments are not included and any that are played in will not be organized by the league but rather by a parent volunteer and they are optional.

<u>Flag Football</u> - A.J. Fitzgerald, the new President of Oxford Flag Football, updated the Commission on the program. There will still be out of town teams playing in the league. Any standalone teams will practice on their own fields and only play games in Oxford. Oxford teams may have non-Oxford residents on them. They will be trying out a draft format for Division 2. This will result in all towns being mixed on teams.

The Commission reminded Mr. Fitzgerald that:

- the number of out of town residents is not to exceed 25%;
- Peddler's Permits are required for all food trucks which requires both Parks and Recreation Commission and Board of Selectmen approval;
- the tournament/travel arm of the league must remain separate from the rec portion of the league:
- Any change to existing age cut-off must be brought to commission.

<u>Pop Warner</u> - Mike Pryde, the new President of Pop Warner, updated the Commission on the program. Mr. Pryde noted that early registration resulted in U12 and U10 having good numbers. While the 4-6 Flag, U14, and their new U8 program has low numbers.

The Commission asked if there is any confusion regarding registration to their 4-6 year old flag program and NFL Flag. Mr. Pryde noted it has caused some confusion in past, but not to date this year.
