# Director's Report

Jackson Cove Eagle Scout projects.

The path from the pavilion to the beach is in a straight line. It is made out of railroad ties and sand, eventually it could become a boardwalk. Benches will be placed along the path. The flagpole, with a solar light, is next to the berm for visibility throughout the park. The bocce court was placed in the middle of the grassy area next to the pavilion.

Trick or Trunk was another success and ran very smoothly. The Turkey Shoot will be on November 14, Tree Lighting will be on December 2.

### Peddler's Permit
