### **Audience of Citizens**

Mike Carponello, 20 Fairview Street, Ansonia, Super Softy was present to ask if he would be able to sell at the Summer Concerts at Jackson Cove. He said he had attended the Board of Selectmen's 5/17/2017 meeting to ask if he could sell at the concerts and they told him to ask the Parks & Recreation Commission. Mr. Carponello asked if he gave a \$100 donation after every concert, if he would be allowed to sell during the concerts.

Tom Federowicz explained that if they let him, they would have to let other vendors sell on that night. He added that Dad's Food Truck is allowed as they sell lite food items and does not compete with the ice cream and other snack items the Parks and Recreation sell to raise funds to complete renovations to the park.

Mr. Carponello noted that H&D Catering had sold ice Cream at the concerts. Kelly Weymer that the Commission never gave them approval.

Mrs. Weymer explained that funds raised go towards renovations to the park. She explained that the Commission is not non-profit and have never and would never donations.

Jackson Cove passes may be purchased on line. The receipts need to be submitted to obtain passes.

An Eagle Scout is doing a project to extend the dock out and build steps to the beach.

Lions Club is looking for suggestions for the \$5,000 they have to spend. Discussion on putting in a sink and another refrigerator in the concession stand. People renting the pavilion have asked if there was a refrigerator to store items.

The benches and planters are in along the walk way. The dock is in.  
Food and Arts Festival is June 11.

The travel camp is sold out. There is a waiting list, but not enough for another bus. Mrs. Nesteriak suggested making the teen camp 5 days next year. Three travel days, one day at Jackson Cove and one day at Colonial Tavern.

June 17 there will be a dedication of the Emily Yish Softball Memorial Field at Aggie Park.
