#### 1.) Zoning Regulation Amendment – Fee Schedule (Appendix A) Public Hearing Closed on 2/4/2013

Vice Chairman Watt began by questioning if the fee schedule is complete and if the Commission finds any discrepancies with what had previously been discussed.

Commission members all agreed that the fee schedule presented to them this evening has incorporated all the changes that were previously discussed in the Public Hearings.

**WHEREAS**, The Commission has conducted a properly noticed public hearing on the proposed amendment to Appendix A; held on January 28, 2014 and February 4, 2014;

WHEREAS; the Commission has considered all testimony presented at this public hearing;

**WHEREAS**; The Commission finds, upon analysis and all testimony submitted, that the proposed amendment is not contrary to the goals, policies and strategies presented within the 2007 Oxford Plan of Conservation and Development;

**THEREFORE**; The Oxford Planning and Zoning Commission adopts the proposed amendment to a Appendix A of the Oxford Zoning Regulations which govern fees for Zoning Applications; subject to the following:

- Such regulations shall be in effect as of March 1, 2014; based upon the following finding:
- The proposed amendment is not inconsistent with the Plan of Conservation and Development; and the Comprehensive Plan of the Town of Oxford.

# The ZEO will present to the Commission any reports/information/or other items deemed necessary.

**Anna Rycenga, ZEO** stated that a preconstruction meeting was held on 2/6/2014 at 2:00 PM for Oxford Town Center (Haynes). She stated that at that meeting the applicant mentioned being concerned about the hours of operation and asked if they could expand the hours beyond 8 a.m. - 4 p.m. She also stated that the applicant would like to have a number of portable crushers on site. She requested that the applicant submit a formal letter to her, which she has handed out to the Commission.

A lengthy discussion ensued amongst Commission members and Anna Rycenga, ZEO.

Alternate David Stocker questioned if this would be covered under the Town's Noise Ordinance.

**Commissioner Cocchiarella** stated that when they approved this application, the idea was that the Commission wanted to expedite the excavation.

Alternate Pete Zbras and Commission Secretary Luff noted that they believed that the noise was the main concern.

**Commissioner Romagna** questioned if the Noise Ordinance would be violated if they started at 7:00 a.m.

**Anna Rycenga, ZEO** noted that the hours of 8 a.m. – 4 p.m. are stated in the regulations for excavation.

Vice Chairman Watt stated that he does not have a problem with a few portable crushers on site as long as they are only running during the 8 a.m. - 4 p.m. timeframe.

Anna Rycenga, ZEO questioned if the portable rock crushers should also be 150' from the project perimeter.

**Commissioners** agreed that all rock crushers should be 150' from the project perimeter.

**Town Planner, Brian Miller** suggested at some point updating the regulations regarding hours of operation for excavation.

Anna Rycenga, ZEO requested a formal motion from the Commission.

MOTION BY Commissioner Cocchiarella to apply the following to application Z-13-138 for Oxford Town Center.

- 1.) Rock crushers can operate between the hours of 8 a.m. and 4 p.m., Monday through Friday.
- 2.) There can be up to 4 portable rock crushers and 1 fixed rock crusher on site.
- 3.) All rock crushers (fixed & portable) must be located 150' from the project perimeter.
- 4.) The hours of operation for activities other than rock crushing are 7 a.m. to 5 p.m., Monday through Friday.
