PUBLIC HEARING – 7:00 P.M.

Z-13-139 [RES-A] 501 Roosevelt Drive, Owner & Applicant: Michael Ligi

(Special Exception - Article 10, Section 3, Site Plan approval, Article 3, Section 25 – 8' Retaining Wall)

Anna Rycenga, ZEO explained to the Commission that Mr. Ligi is present because he has requested to build a retaining wall that is 8 feet in height. She stated that per the Zoning Regulations, Article, 3, Section 25, any retaining wall over 6 feet in height is not under her jurisdiction, it must be approved by Special Exception/Permit by the Commission.

Secretary Pat Cocchiarella read correspondence dated October 12, 2013 from Allan Young, P.E. regarding this application. (Attachment A)

Anna Rycenga, ZEO informed the Commission that she sent the applicant a Notice of Violation/Cease and Desist Order on July 8, 2013 because he had constructed the wall without securing the proper permits. She also stated that the Building Department and Inland/Wetlands Department also had the applicant in violation.

Anna Rycenga, ZEO stated that it is apparent that the wall is tilting toward the river. She commented that originally the wall was going to be taken down, but the applicant is now proposing to reconstruct the wall.

APPLICANT PRESENTATION

Michael Ligi, 501 Roosevelt Drive, submitted the return receipt cards and the photo of the sign that are required for the Public Hearing process. He stated that originally there was a wall but when he moved in it was in disarray. He stated that he did the work without a permit and now he would like to make it right by getting the proper permits and hiring an engineer to build it to the towns specifications.

Paul Bombero, L.S., stated that the wall they are proposing is from 4 to 8 feet in height. He commented that he will revise the plans as requested by the Town Engineer. He stated that the wall be taken down and then constructed in conjunction with a licensed engineer.

Allan Young, P.E., stated that the plans that were submitted need to be clarified and the engineer needs to provide more clarity and detail to what they are actually proposing.

Anna Rycenga, ZEO stated that this application still needs wetlands approval.

Harold Cosgrove noted that if this wall ever has graffiti on it, that it be a condition that the graffiti be removed by the owner. He also stated that he would like to have the wall backfilled in order to add more continuity to the land.

Anna Rycenga, ZEO requested copies of photos from the applicant, Mr. Ligi.
