NEW BUSINESS

1. Z-16-191 [COMM] - 308 Oxford Road

Owners: Wally Archer

Applicant: William Werner – "Naugamatic Watch Company"

Application for Use Permit: (Watch repair & retail)

ZONING ENFORCEMENT

Steven S. Macary, ZEO noted that he has received complaints about the following properties:

1. 16 North Larkey Road – Attorney Fran Teodosio submitted a complaint dated 8/2/16 with pictures attached. He stated that there are still personal vehicles being parking in the "panhandle" area that was included in the final decision of the Commission as being in violation of the approved permit.

The Commission requested Steven S. Macary, ZEO to go out and inspect the property unannounced a few times over the next two weeks and to report his findings to the Commission at the next meeting.

2. Goodwill Site Plan – Lorraine & Ralph Tirella of 11 Larkey Road came before the Commission to discuss many concerns regarding Oxford Towne Center and the Goodwill site plan.

The Commission concluded that they would review Mrs. Tirella's correspondence (letter with pictures included) and send any information to the necessary parties for review.

After some discussion, the Commission decided that because of the amount of information they received they would like to put this on the agenda for the first meeting in September. A copy of Mrs. Tirella's letter is on file in the Planning & Zoning Department.
