First Selectman George Temple stated that he believes that there should be a separate account for Planning & Zoning that can be drawn on for professional fees and then any monies not expended should go back to the developer. He stated that he will discuss this with Jim Hliva, Finance Director and see how they can move forward to handle this situation and make any changes that are necessary.
