(Site Plan for Construction of a Garage, Canopy, and Building)

Dominick Thomas, Attorney for the applicant was present. He told the Commission that he spoke to Jim Galligan, P&Z Engineer; Mr. Galligan said that there is no need for a buffer. He handed out an 11x17 photo of the property to indicate that buffers would not be necessary, even when looking at the site from different areas in relation to Route 67. He referred to the proposed text amendments that are being reviewed by the Commission and stated that in relation to his client, there will be no processing,

but he would not meet the building requirements. He noted that the application has been approved by OCCIWA. He also explained that the proposed business would have a minimal impact on traffic.

# Text Amendments to the Oxford Planning & Zoning Regulations

**Proposed Amendments to the following Articles:** 

Article 2 - Definitions, Article 10 - Special Exceptions (Contractor's Yards), and

Article 14 - Earth Re-grading & Excavation.

### Public Comments regarding the proposed Text Amendments:

Attorney Dominick Thomas, 315 Main Street, Derby, discussed the following in relation to the proposed amendments; there is nothing in the proposal that eliminates Schedule C, possible conflicting interpretations of Article 14, Section 14.1.4 and Section 14.1.5, clarity of definitions related to "minor" excavation, special exception approvals for "minor" and "major" regarding for site development, any processing proposed by an applicant is prohibited with the requirement of a building.

Mark Oczkowski, requested that the Commission keep the hearing open and he will have comments for the next hearing.

Attorney Steven Kulas represents homeowners currently opposed to rock crushing activities near their homes. He noted that "Schedule C" should be eliminated; it conflicts with the proposed text amendments. He commented that his clients are opposed to the storage of outside materials on site; he mentioned that the earth materials listed do not include concrete or demolished building materials. He commented that any earth processing operations should be contained within a building.

Commissioner John Kerwin asked that Attorney Kulas state for the record that the homeowners that he represents are residents of Oxford.

Attorney Kulas stated that he represents homeowners in the vicinity of a contractor's yard located on Nichols Road.
