Siuyan Cao, Civil 1, engineer representing the applicant was present. He outlined the application for the Commission. He stated that the earthwork is required in order to prepare the site for future development. He noted that the existing site is approximately 10 feet lower than the road, therefore they have to import over 13,000 cubic yards of material onto the site. He noted that the application is consistent with the conceptual plan that was approved in 2017, and submitted a transportation route. He noted that truck traffic will be restricted to 8 am to 5 pm, Monday through Friday. He also noted that they anticipate the filling operation to be completed within two months.
