Chairman Cocchiarella called the meeting to order at 7:35 PM.

VI. Regular Meeting Business

ITEM 1: CT General Statute 8-24 Referral - Oxford Town Park - Oxford Road/Route 67

Jeff Luff, Economic Development Coordinator presented the current phase that has begun at the old Oxford Center School. He also explained the future plans and various uses of Oxford Center School location. Commissioners asked questions regarding the excavation, the demolition of the campus buildings, asbestos abatement, and the truck traffic generated from this phase of the project.

Curt Jones, Civil 1 Engineering is the Town's engineer for the project and answered some of the Commissioners questions.
