We have asked the CT Public Utilities Regulatory Authority for permission to merge Heritage Village Water into Connecticut Water, which have been sister companies for 4 years. It will eliminate duplicate record keeping required as a standalone company. You'll be served by the same employees and the merger will not affect water rates. Pending PURA approval, we expect the change to occur in late summer.

For Heritage Village Water Customers

We are holding base water and wastewater rates at current levels until at least 2020. Under the former ownership, the Connecticut Public Utilities Regulatory Authority (PURA) had ordered the addition of a Water Revenue Adjustment (WRA) on water and sewer bills issued after April 1, 2017. The exact percentage to be applied to your total water and sewer accounts is determined annually based on the company's actual year end revenues. If the company collected more than authorized in their last rate case, a credit will be applied; if the company collected less than authorized in their last rate case, a surcharge will be applied. The WRA surcharge/credit appears as separate lines on your bill.

In the future, the company may apply to PURA for a Water Infrastructure and Conservation Adjustment (WICA) charge if it is determined that there are eligible capital projects that need to be done before 2020. WICA allows water utilities to replace eligible aging infrastructure (water mains, valves, and hydrants) through a modest surcharge on water bills between general rate increases. Customers would be notified before a WICA is implemented.
