4. Approval of Minutes From August 26, 2020 Regular Meeting:

Approval for Contract Change Order #PCO 86 from O&G in the amount of \$15,910.00, to add a fence between QFS and OMS per staff request (rock drilling is excluded from PCO) was tabled. Dr. Miller will set up a site walk through for committee members, as well as the QFS principal to discuss further.

- -Contract Change Order #PCO 88 in the amount of \$585.00, from CM contingency, to add one hand dryer for the kitchen toilet
- -Contract Change Order #PCO 89 in the amount of \$1,467.00, from CM contingency, to add joint sealant at the west curtainwall joints to close the gap between brick and aluminum
- -Contract Change Order #PCO 90 in the amount of \$4,308.00, from GMP allowance, to add Way finding Signage per PR 020
- -Contract Change Order #PCO 91 in the amount of \$1,114.00, from CM contingency, to add Spring loaded indicators on fire hydrants per FM request

Approval for Contract Change Order #PCO 92 from O&G in the amount of \$15,027.00, from CM contingency, to add fencing around propane tanks per FM request (rock drilling is excluded from PCO) was tabled until further discussion takes place with the fire marshal.

6. Reports From Contractor/Consultants:

- G. Kotait (O&G) shared Monthly Progress Report No. 14 through August 2020, including photos of the school building on the first day of school. As of this report, available funds are \$477,476.00.
- J. Hopkins (Tecton) informed the committee that he will have cost and designs regarding exterior canopy. The school building sign had to be removed and relocated to allow for better visibility. Ponding on the baseball field is being addressed, and there needs to be modifications to the fields to better meet the needs of the players.
- K. DePersia (CSG) received a response from the state indicating COVID claims would not be reimbursed. She is finishing up with FF&E, tracking invoicing, and collecting punch list items from staff.
