The beginning of February and August is when the legal notice goes in the Voices. The appeals come into the Assessor's office, are copied, and then this Board is notified for them to be picked up.

The Board welcomed our newest member, Martin Wing. He has not taken the class yet, but spoke with Bill Gaffney who is trying to set up a class here in Oxford, or somewhere in our area. Linda Czaplinski had mentioned to Martin to go to the Assessor's Office to get a copy of the handbook. Linda Czaplinski mentioned that the training cost comes out of the Board's budget.
