Nomination Carried: Unanimous

Moderator Scott Halstead read the eligibility to vote at a town meeting, according to Oxford Town Charter.

Scott Pelletier moved, seconded:

Shall the Town of Oxford approve an appropriation, in the amount not to exceed \$47,000.00 to be taken from Capital and Non-Recurring, for the purchase of a Public Works 2017 Dodge Ram 5500 4X4 truck; as approved by the Board of Selectmen 1/17/18 and Board of Finance on 1/22/18?

There being no discussion the moderator called for a vote on Item 1:

Motion Carried: Unanimous

Scott Pelletier moved, seconded:

Shall the Town of Oxford approve an appropriation, in the amount of \$115,000.00 to be taken from the General Fund, for the purchase of new Library furniture; as approved by the Board of Selectmen 1/17/18 and Board of Finance on 1/22/18?

Discussion:

Jack Kiley, Board of Finance Chairman commented that he saw something about ION Bank donating furniture. Those present from the Library Building Committee agreed they heard nothing about this, there being no other comments or questions the Moderator called for a vote.

Motion Carried: Unanimous

Scott Pelletier moved, seconded:

Shall the Town of Oxford approve the funding in the amount of \$7,080.00 to be taken from General Fund, which was paid into the General Fund by Garden Homes and the request from WPCA is to appropriate the money to pay for the engineers; as approved by the Board of Selectmen 1/17/18 and Board of Finance on 1/22/18?

Discussion:

Scott Halstead (WPCA) explained that this was funds received by Garden Homes, but because of the Charter they have to be deposited to the General Fund and then acted on. There being no other comments or questions the Moderator called for a vote on Item 3.

Motion Carried: Unanimous

Scott Pelletier moved Item 4, seconded:

Shall the Town of Oxford approve the funding in the amount of \$2,080.00 to be taken from General Fund, for WPCA to pay the engineer for putting in sewers on Route 67 near Pleasant Valley Professional Plaza; as approved by the Board of Selectmen 1/17/18 and Board of Finance on 1/22/18?

Scott Halstead once again explained that these are funds received for this work. There being no other comments or questions the Moderator called for a vote.

Motion Carried: Unanimous

Scott Pelletier moved to adjourn, seconded.
