

Town Meeting
March 21, 2018

The meeting was called to order at 7:00PM by First Selectman George Temple. Town Clerk Margaret A West-Mainor read the call and return of posting. Scott Pelletier nominated Scott Flaherty, seconded. There being no other nominations First Selectman Temple called for a vote.

Nomination: Carried

Moderator Flaherty read the eligibility to vote at a town meeting.

Scott Pelletier moved Item 1, seconded.

ITEM 1 Shall the Town of Oxford approve an appropriation, in the amount not to exceed \$42,760.99 to be taken from Capital and Non-Recurring, for the purchase of a 2017 Ford Utility Police Interceptor All Wheel Drive vehicle; as approved by the Board of Selectmen 1/17/18 and Board of Finance on 2/26/18?

Discussion: First Selectman Temple asked Sergeant Dan what they would do with the old car and he responded, construction. There being no other comments or questions the Moderator called for a vote.

Motion Carried: Unanimous

Scott Pelletier moved, seconded.

ITEM 2 Shall the Town of Oxford approve an appropriation, in the amount of \$6,500.00 to be taken from Capital and Non-Recurring, to hire an engineer to prepare a survey for the proposed new fuel storage tanks at Public Works; as approved by the Board of Selectmen 2/7/18 and Board of Finance on 2/26/18?

Discussion: Scott Pelletier explained that this was being done to get the tank out of the ground and for safety reasons as well. There being no other comments or questions the moderator called for a vote.

Motion Carried: Unanimous

Scott Pelletier moved, seconded.

ITEM 3 Shall the Town of Oxford approve the funding in the amount of \$1,250.00, to be taken from Capital and Non-Recurring, for Kevin Tymon, Mason Contractor, for the Chimney Restoration Project at Riverside Fire Station; as approved by the Board of Selectmen 2/21/18 and Board of Finance on 2/26/18?

Discussion: First Selectman Temple asked if there were other quotes for this and Scott Pelletier explained that there was and it went through the process.

Motion Carried: Unanimous

Scott Pelletier moved, seconded.

ITEM 4 Shall the Town of Oxford approve the funding in the amount of \$9,000.00 to be taken from Capital and Non-Recurring, for the purchase of a portable Hurst Pump for R54; as approved by the Board of Selectmen 2/21/18 and Board of Finance on 2/26/18?

There being no questions or comments the Moderator called for a vote;

Scott Pelletier moved to adjourn, seconded.
