**Audience of Citizens**

Mr. & Mrs. Frederick Raskopf, 552 Caddie Court, were present to dispute their sewer bill. Mr. Raskopf went over a chart he had prepared. He noted that there has been a 49% increase in cost.

Mr. Halstead explained that his chart was done in quarters; the sewer user fee is only based on the first and fourth quarters. It was noted that there may be a slow leak in the plumbing causing an increase in water usage.

**Old Business**

Oxford Commons – have submitted revised plans to the WPC engineer.

Discussion on replacing the Towner Lane generator. It needs to be jumped to get it to run. Also two check valves are needed to prevent sewage from entering the basements of the neighboring houses. These basements are lower than the pump station.

**MOTION:** Bob Farnum moved to request from the Boards of Selectmen and Finance \$65,000 to replace the generator and \$10,000 for two check valves. Second by Bob Peck. Motion unanimously approved.

**Report from Staff**

Discussion on the Perkins Road pump has been changed out five times. It will cost \$10,000 to rebuild. A capital request of \$30,000 is being made in the 2019-2020 budget to replace the Roto phase unit.
