Email from Jim Stewart, Director of Naugatuck Public Works. Mr. Stewart noted complaints received from the Oxford Sewage Discharge and asked that it be investigated.

Mr. Halstead said he metered for H₂S, with no recordings of odors. Permanganate is being used. It is also used by Naugatuck for odor control?

Mr. Peck noted he had toured the area with Mr. Halstead and there was an odor coming from the Middlebury manhole.

Mr. Halstead noted that the complaints of odors occur in the area where Middlebury, Naugatuck and Oxford lines are combined into one main trunk line. Mr. Halstead contacted Mr. Stewart about evaluating all of these lines. Mr. Stewart has not responded.
